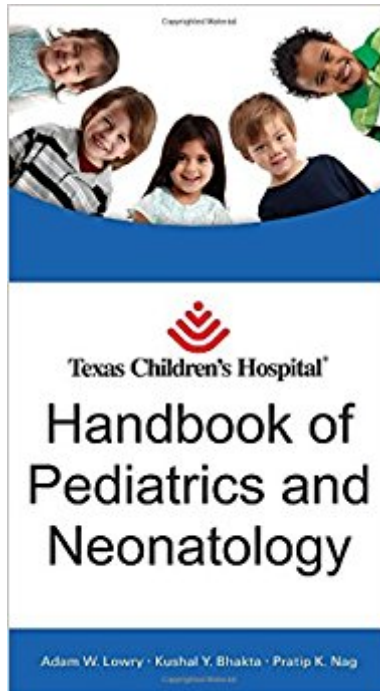

Good book

Comparing this book to some other peds review books this one is ok but not great. The content is good and there are plenty of references that are of good quality. The handbook covers many topics and would do just fine for residents or hospitalists. The neonatology section is very nice as well. For outpatient pediatrics there it is less useful. My biggest concern about this is the quality and build of the handbook. It is a thicker plastic cover with 3 ring binder inside, the pages are very thin and tear very easily. Not rugged in the least. Comparing this to other peds handbooks that I have I would rank: 1) Philadelphia Guide, Inpatient Pediatrics 2) Washington Manual of Pediatrics (especially good for outpatient use as well) 3) Texas Children's Handbook (this book) 4) Harriet Lane. No book is perfect, but I think if you have #1 and #2 of the above you should be pretty well covered.

Well organized and easy to use as a "quick and dirty" desktop reference. Would like more info added on genetic syndromes. This is a great resource for a nurse case manager as well as medical students and residents.

As a practicing hospital based doctor I bought the kindle version as I wanted something better than the Harriet Lane Handbook. Imagine my horror as I discovered that at the end of each e-chapter it says "available at Accesspediatrics dot com" and provides links to the final parts of that chapter. On going to accesspediatrics dot com I see I need pay "only" \$595/yr to access the full content of the book and the rest of their pediatric education library and learning tools. Or I can pay just "\$34.95" for 24hrs access! Can you believe it? They are selling an e-book to draw traffic to their expensive subscription website. So I pay \$26 for an incomplete book and an invitation to spend \$600/yr to get the full book and resources I don't want or need??? All of this without any mention of this policy on buying the e-book. I'm guessing this will be the case with others of McGraw-Hill's ebook medical titles, looking at the "access" website. I've been in touch with the publisher without satisfactory result, now I'm trying . Unfortunately I didn't realize this bait-and-switch until after the 1 wk ebook

return deadline had passed.** Update, made an exception and refunded my money, and said they would address it with the publisher. I hope so. Beware McGraw-Hill Medical books. Thanks !

The Texas Children's Pediatric handbook is essential for any pediatric resident on the wards or in clinic. My Harriet Lane is gathering dust as this book is a replacement and more. It has a great section on antibiotics which goes over each type of antibiotic and what it covers. It also has an amazing table of gram negative, gram positive, anaerobes etc and which antibiotics work best. Its fluid and electrolyte section is excellent as well. Also, the pocket card covers almost every emergency situation and will get you out of codes, seizures, asthma exacerbations, and many other emergencies without issue. Many of my fellow residents and interns have seen this book and too switched over. It's a must for anyone going into pediatrics.

Note that most of the contributors are junior faculty, house staff, and fellows. When I need help at night I don't seek out an intern. I prefer to hear the words of the recognized expert in the field. In addition it is difficult to use to locate clinically useful references. I've tried many other electronic textbooks and this one clearly does not stand out. As a practicing physician I would not wish to be caught in the middle of the night dependent upon this as a reference. The search function brings up many unexpected references and there is little guide on which of the many, many hits will prove useful. Consequently, this occupies no space on my iPad. I find uptodate.com a much more reliable resource.

I'm a pediatrics intern, and bought this book for my Kindle. It is jam packed with extremely useful information that I can use at the bedside. The table format makes it so easy to read...I don't have to weed through pages and pages of prose to get to what I want. I HIGHLY recommend this book for any trainee in Pediatrics. I even saw one of my attendings using it!! EXCELLENT handbook!!

This a great handbook that I can carry with me. I'm an intern and this book has been a great help along my long journey to starting my career.
