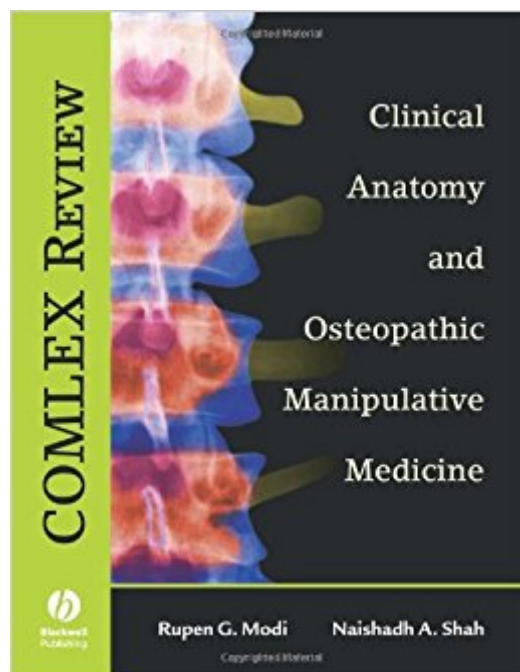

Rupen Modi and Naishadh Shah are both currently fourth year osteopathic students at the NY College of Osteopathic Medicine (NYCOM). They were both selected as Undergraduate Teaching Fellows at NYCOM (a merit based scholarship). Modi is a Fellow for the Department of OMM and

Shah is a Fellow for the Department of Anatomy. Under the fellowship program they will invest an extra year teaching their respective subjects to the first, second and third year NYCOM students before graduating in 2005. They are also enrolled in the School of Management at the NY Institute of Technology, and are anticipating completion of their MBAs by 2004.

Better than Savarese for an anatomy review, there are images at the beginning of and throughout each chapter but not a great review of techniques. If you're very familiar with techniques (2nd year or beyond) I'd recommend this as a refresher for step 2 but I think Savarese is better when first learning OMM.

I am studying for the COMLEX 1 right now and it is a great review of everything...I wish I had had this book for the first two years of medical school, I think it would have helped me understand the basics. In addition, it would have helped me for OMT practicals, because you can never talk your way through OMT enough! Always keep talking! I think this will definitely help me out, glad I bought it and I will definitely use it for the future Levels of COMLEX.

Well done for Anatomy as well as Osteopathic Manipulative Medicine.

Although very detailed in anatomy the application to osteopathic practice and usefulness as a board review tool is minimal.

I like this book. The set up is easy to understand and follow with the high yield information in bold.

I was expecting this book to have more information on manipulation techniques and pictures to accompany them but that was not the case. The book has been helpful on occasion when learning osteopathic principles and anatomy.

You sent me three copies when I asked for one. I cannot return the two surplus copies as your system blocks my attempted return.

I was bit skeptical when I borrowed this book from our school library- it seems it was written by two students. But after reading the first 2 chapters, I immediately bought my own copy. The beautiful thing about this book is that it finally correlates anatomy with OMM- so it actual covers those "in

between" questions that the other review books fail to discuss. The pictures are EXCELLENT! They actually help to make sense of some of the more difficult concepts. I'll let you know how my Step II exam goes- but I would have loved to have this book around when taking Step I as well. Also, the beginning of the book has a little chart that tells you what chapters to read for each COMLEX exam- takes the guess work out of studying. I am definitely doing better on my practice exams- wish me luck for the real deal.
